Cancellation Policies [90 to 45 days prior to arrival (1 Jan / 15 Feb)]

LODGING:

Reduction of Room Block:

Up to 20% of Room Block may be cancelled up to 45 days prior to arrival
Group must maintain ten (10) rooms to qualify for quoted rates

Cancellation Penalties in the event the group cancels entirely:

Group may cancel without penalty prior to November 29, 2019

Group cancellation from 90 to 45 days prior to arrival, a fee of 1 night room rate plus taxes will be charged, per room.

AIR TRAVEL:

United Airlines

- Confirmed number of Guests using Air Travel (Air Utilization Date) – January 2, 2020
- Names and TSA information of Guests using Air Travel – February 10, 2020
- Ticketing date for Air Travel – February 25, 2020
- Deposit is refundable up to 90 days prior to departure. Up to 10% of seats held between 89 and 30 days may be cancelled without penalty (90% utilization).
- Seat assignments for groups may be assigned at booking subject to availability but are not guaranteed. Any unassigned group seats will be assigned at check-in.
- Once ticketed and a passenger cancels, travel for new ticket must start within one year of date original ticket was issued. Additional restrictions may apply.
- Minimum for group is 10 passengers traveling together from Gateway City. If below 10, fare may change. Reducing your group to 10 will result in a 100% "utilization requirement" of 10
- One free name change is allowed per ticket outside of 7 days prior to departure. Name changes within 7 days prior to departure are charged a \$100 fee. No name changes allowed less than 24 hours prior to departure.

All unused air seats without a name associated with them will be released at the time of ticketing and the group is responsible for any utilization fees associated with the cancellations.

LIFT TICKETS:

Once ticket order is placed, any changes or cancellations up to 7 days prior to arrival are subject to a \$20 change fee. Any cancellations within 7 days of arrival are non-refundable, non transferrable. Any partially used lift tickets are non-refundable. Some exceptions may apply if a valid doctor's note is provided and only if participant was injured on the trip. Any unused lift tickets or partially used lift tickets with doctor's note must be mailed to Sports America and refunds will be processed.
